Alex Spitzer Candidate: Member-at-Large

I have been a member of the National Dance Society for nearly four years. I love our motto of *Dance For All* and it is founded in the belief that dance is an inclusive, healthy, lifelong activity that should be available to everyone. In my senior year in high school, after seeing an article about a dancer in a wheelchair and taking that article to my theatre teacher, who also taught a dance class. He was willing to give me the opportunity to take a dance class and try it. That one opportunity has led me to dancing professionally for 33 years and getting a Bachelor of Arts in Dance from Texas Woman's University.

If I get the opportunity to serve as a member-at-large on the Board of Directors for the National Dance Society, I want to start helping dancers with disabilities and dance companies that work people with disabilities, connect with each other and learn from each other in different ways than they have previously. With that helping, I want to develop dance education strategies for disabled and abled. There are different levels of dance for disabled individuals. Some that will need to be specialized. Others where someone disabled, or in a wheelchair, can be involved in regular dance classes or workshops either in public/private schools, colleges, or professionally. I want to work with dance educators and help them know how they can be inclusive with disabled and able body students together in the same class. This is the beginning and some of my vision for dance and disability. I would love to see this grow through the National Dance Society.
